


- 1. All parameters NOT specially mentioned are measured at 230VAC input, rated load and 25°C of ambient temperature.
- 2. Ripple & noise are measured at 20MHz of bandwidth by using a 12° twisted pair-wire terminated with a 0.1 uf & 47uf parallel capacitor.
- 3. Tolerance: includes set up tolerance, line regulation and load regulation.
- 4. Derating may be needed under low input voltage. Please check the static characteristics for more details.
- 5. The power supply is considered as a component that will be operated in combination with final equipment. Since EMC performance will be affected by the complete installation, the final equipment manufacturers must re-qualify EMC Directive on the complete installation again.
- 6. Length of set up time is measured at first cold start. Turning ON/OFF the power supply may lead to increase of the set up time.
- 7. Suitable for indoor use or outdoor use without direct sunlight exposure. Please avoid direct exposure to sunlight and immersion in water for over 30 minutes.








### RECOMMEND MOUNTING DIRECTION
